

Smt. Uma Sankar is presently serving as Regional Director for Tamil Nadu and Puducherry, Reserve Bank of India. She has been also appointed as RBI Nominee Director on the Board of Punjab National Bank.

Smt. Sankar joined the Reserve Bank of India as a Direct Recruit Officer in Grade B in June 1993. She has served in Offices of RBI at Ahmedabad, Pune, Mumbai, Trivandrum and Chennai and has wide experience in various fields of central banking such as, supervision of Banks/ Non-Banking Financial Companies/ Urban Co-operative Banks, training of personnel, resolution of banking related complaints of the common man as Banking Ombudsman, enhancing financial literacy among the public, etc.

Prior to joining the Reserve Bank of India, she worked in the Life Insurance Corporation of India (LIC) as an Assistant Administrative Officer.

Smt. Sankar holds Master in Business Economics and Bachelor's degree in Commerce (Honors) from Delhi University. She was awarded the prestigious Golden Jubilee Scholarship 2008 by the RBI. She was also awarded with M.Sc. in Management, Organisations and Governance from London School of Economics and Political Science, London, UK.
